CRAFT VENDOR INFORMATION AND GUIDELINES

Greetings, Vendors! It's time for the Old Settler's Music Festival!

Please read through this information before applying to be a vendor

General information about the Old Settler's Music Festival

- **Location of the festival**
1616 FM 3158, Tilmon, Texas (just southeast of Lockhart).
Enter Old Settler's into Google Maps and it will take you there.
- **Estimated audience attendance**
We look forward to 5,000 music lovers Friday and Saturday and 2,500+ per day on Thursday and Sunday.
- **Vendor correspondence with festival**
All vendor correspondence will be conducted via email. Please check your email regularly prior to the event to consider any notices or changes in addition to load-in time scheduling. Be sure to also check junk/spam folders.

What we are looking for in our vendors

OSMF is a juried festival. We wish to offer a high-quality variety of food and crafts. While our emphasis is on quality, handmade and/or local items, we are not a "handcrafters only" or "local only" event. We pick booths based on, but not limited to, the following criteria:

- **Products**
We look forward to offering a quality mix of merchandise and crafts for our attendees. High-quality, handmade local items and services are highly emphasized and encouraged.

- **Presentation**
Unique, professional displays of booth and staff that widely complement the lovely setting. We do not encourage carnival/fairground displays of attraction.
- **Vendor community and/or county residency** are taken into consideration.
- **Vending Experience**
Experience is a plus, but we are open to those vending for the first time. If this is your first vending experience, please read the guidelines thoroughly to grasp what will be expected from your operation.

In addition to following the festival/vendor guidelines, we insist on a staff that is both attentive and courteous to our patrons. Keep the Old Settler's vibe alive!

Vending Fee Includes

- **Plot**
Craft: 10' wide (front) x 10' deep
- **Passes**
Craft: Two (2) four-day general admission passes with camping (Thur-Sun only) and one (1) vending parking permit (good for Meadow Lot Parking and Camp Armadillo Parking only). Additional vendor wristbands can be purchased when you check in.
There is no vendor car parking in the wooded area of the campground.
- **Tent**
Each craft booth is 10' wide x 10' deep and most will be under a shared tent. OSMF provides the tent. Vendors are responsible for closing and securing the front of their booth at the end of the night.
- **Electric**
Craft: 1-110v/20amp
Additional power needs must be specified and paid for prior to the event.
All electrical equipment such as power strips, multi-outlet taps, extension cords, etc., must be grounded and suitable for outdoor use. Lighting and electrical accessories are to be furnished at the vendor's own expense.
- **Promote Your Booth**
Company name, contact information, and prices will be listed in the vendors' section of the OSMF website. The earlier you submit your final price list, the sooner it will appear on the website.
- **Program Listing**
All vendors who have paid their vendor fee by the 9/06/21 deadline will have their company name listed in the official 2021 OSMF program.

General Booth Information

- Booths are laid out on grass.
- All equipment, supplies and overstock must be stowed and hidden within the space provided.
- No unsightly materials or equipment should be visible to the crowd. This is your store front, so it should appear to be inviting and appealing to our patrons.

- **Hours of operation extend beyond dark. Vendors are responsible for furnishing and lighting their own booth.**
- Gate opening is commonly scheduled an hour before music acts are set to perform. **All vendors are expected to be staffed and ready for business when the gates open until the final performance of the last act has concluded.**

Product Restrictions

- Booth acceptance is based on the understanding that you will sell only those items listed in your application. You may not sell any additional items without our express written consent. If we specify that you may not sell certain items, they must be omitted from your product line. In this case, we will contact you before depositing your booth fee.
- Vendors may not sell any item with the Old Settler's Music Festival (OSMF) logo(s) without the express written consent of OSMF. Additionally, you may not sell any item with the name or image of any act playing the festival, without express written consent of said artist.
- You may not sell drug paraphernalia, tobacco of any kind, or laser pointers/flashing items. Craft vendors may not sell food or drink.

Booth Placement

Booth spaces are pre-determined and not subject to change. If you have specific requirements in order to operate, please list such in the special requirements portion of the application.

Please do not contact us personally to request a specific space. All spaces are great spots! If you have a preference, please note such in the special requirements area of the application, and your request will be taken into consideration. Vendors are placed at the sole discretion of OSMF staff, and placement during load-in is final.

Booth/Display Must Haves

- An attractive, professional, maintained appearance
- Quality merchandise
- Courteous, friendly, music loving personnel
- Displays secured against wind/weather
- Complement the natural setting of OSMF

Signage

Vendors are required to provide a sign for the front of their booth, displaying company name. You may have a maximum of 2 banners. You will also want to display your menu and prices visible from 10' away.

Additional Information

- **Camping**
While camping fees **ARE** included with vendor fee, RV fees, discounted passes for additional workers, and additional vendor parking passes are not. Discounted camping fees for vendors are limited in the number of working passes for booths.

- **2021 Pass and Permit Fees**

- Additional vending Meadow Lot Parking Permit \$30
- RV pass (*includes one Parking Permit and one Electrical Permit*)
 - Over 18' camping vehicles \$205
 - 18' or under camping vehicles \$140
- Electrical Permit (for tent camping) \$50

RV passes must be purchased online or from the Campground Box Office. Primitive spots are on a first-come, first-pick basis. No reservations are available.

- **Insurance/Waiver**

Vendors must be responsible for their own insurance coverage with additional certificate holders (OSMF) required. *In addition, all vendors will be required to sign a release of liability waiver upon checking in.* No vendor will be allowed to set up until the waiver is signed.

- **Don't forget that you must have a Texas State sales tax permit to vend at OSMF.**

Hours of Operation

Thursday (10/21/21) – campground	3 pm – Midnight
Friday (10/22/21) – arena	1 pm – Midnight
Saturday (10/23/21) – arena	10 am – Midnight
Sunday (10/24/21) – campground	9:30 am – 5:30 pm

NOTE: Campground vendors are open Friday and Saturday as well, and campground vendors may open before the arena opens. Early morning hours are allowed if quiet is observed.

Arena Booth Information

- **Loading In at the Arena**

Thursday 10/21 and Friday 10/22

- **Specific load-in times to be communicated approximately 2 weeks before the festival.** Please arrive 15 minutes prior to this time. If late, you will be placed on standby.
- Scheduled arrivals take priority. Attempts to load in early without a scheduled time is prohibited. Attempts to load in after Friday at noon will be prohibited.
- No late set-ups unless coordinated prior to the event.
- Once loaded in, vendors are unable to bring their vehicles back in until load-out time.
- Everyone going through the gates will be subject to the same search restrictions.

- **Loading Out**

All arena vendors are to load out on **Sunday, October 24, 2021 by noon.**

- For liability purposes, NO vendor vehicles are permitted in the arena while patrons are present. Vendors who don't comply risk ejection and will not be invited back.

Prohibited Items & Actions

- Generators or propane lamps
- External video displays
- Flashing, blinking, chasing lights of any kind. String lights are permitted if they are constant-on LEDs located discreetly *inside* the booth. Clamp lights are encouraged.
- Music from your booth must be silenced when artists are performing on stage.
- Vendors selling instruments are responsible for making sure a respectable noise level is achieved and does not interfere with the musical acts on stage nor their neighbors' ability to do business.

Other FAQs

- **Security**
OSMF provides security during all overnight hours. Vendors are responsible for covering and securing their booths/merchandise.
- **Trash**
A dumpster is provided onsite. Vendors are responsible for the cleanliness of both booth and plot spaces. All trash must be removed and/or placed in the proper receptacles before loading out. Failure to do so will jeopardize chances of return to future events.
- **Pets**
NO PETS of any kind are allowed. This includes on the festival grounds, festival/staff parking areas, and campground. Leaving an animal in a vehicle during the festival is prohibited and will result in animal control being summoned and your departure from the festival.
- **Ice**
Bags of ice will be available for purchase from the bars onsite during festival hours. If vendor operations require ice before the bar opens, vendor must plan accordingly at their own expense.
- There are **NO REFUNDS**.

Timeline

Monday, September 13	DEADLINE FOR VENDOR PAYMENTS Only vendors who pay by this date and submit their materials to OSMF will be included in the printed program.
Thursday, September 23	Certificates of Insurance due and a copy of your Texas State Sales Tax and Use Permit

Thursday, October 21	Load in 3-5 pm Exact times will be communicated approximately two weeks prior to the event.
Friday, October 22	Load in 9 am-11 am Exact times will be communicated approximately two weeks prior to the event.
Thursday, October 21 to Sunday, October 24	Old Settler’s Music Festival
Sunday, October 24	Load out Timing will be communicated in advance

2021 Vendor Art/Craft Booth Fees

Booth fees include a 10’ by 10’ tent provided by OSMF, two vendor passes with camping (Thur-Sun only), one vending car parking permit, access to electricity for your booth, program listing, newsletter mention, and inclusion on our website (provided materials are supplied by the deadlines).

Important Information

- **Detailed information and photos of your products and booth must be included.** Applications submitted without pictures and descriptions of products will not be considered. **PLEASE INCLUDE COMPANY NAME IN YOUR FILENAMES!**
- All jpgs become property of OSMF.
- Vendors are permitted only to sell items or services that have been submitted in the merchandise list.
- All vendors are required to submit a copy of their Texas State Sales Tax permit, and are to display said permit in their booth during hours of operation
